Tenure of the NGOs shall be two (2) years.

The functions of the Board shall be as follows:

- (i) Execution of the management scheme for the Ridge forests as the green lungs of Delhi;
- (ii) Protection of the boundary and boundary fences of the Ridge;
- (iii) Preparation and execution of detailed plans for upgradation of the Ridge in accordance with sound silvicultural practices applicable to city forests and natural resources;
- (iv) Control of the usage by the public of such areas of the Ridge forests as may be declared as "open" by the 'Board'.
- (v) Ensuring that there are no encroachments in excess of the areas allotted to the lawful allottees, till they are shifted from the Ridge forest under appropriate orders.
- (vi) Any other functions ancillary to the above purposes.
- (vii) The Board may co-opt for any of its meetings not more than two persons having special knowledge of forestry, regional ecology, nature conservation and related subjects.
