- (2) The functions of the Board shall be as follows:-
- i) Execution of the management scheme for the Ridge forests as the green lungs of Delhi ;
 - ii) Protection of the boundary and boundary fences of the Ridge ;
 - iii) Preparation and execution of detailed plans for upgradation of the Ridge in accordance with sound sylvi cultural and practices applicable to city forests and nature resources.
 - iv) Control of the usage by the public of such areas of the Ridge forests as may be declared as "open", by the 'Board'.
 - v) Ensuring that there are no encroachments in excess of the areas allotted to the lawful allottees, till they are shifted from the Ridge forest under appropriate orders.

- vi) Any other functions ancillary to the above purposes.
- (3) The Board may co-opt for any of its meetings not more than two persons having special knowledge of forestry, regional ecology, nature conservation and related subjects.
