Subs: Constitution of Ridge Management Board

Lt. Governor, Delhi is pleased to constitute the Ridge Management Board, consisting of the following members:-

1.	Chief Secretary, Delhi	Chairman
2.	Vice-Chairman, DDA	Member
3.	Secretary (Env. & Forest), Delhi	Member
4.	Finance Secretary, Delhi	Member
5.	Representative of Indian Society of Environmental Management (NGO)	Member
6.	Representative of Prakrti - Centre for Environmental Protection & Development (NGO)	Member
7.	Conservator of Forests, Delhi	Member - Chief Executive (Post under creation)
8.	Deputy Conservator of Forests, Delhi	Secretary

(2) The functions of the Board shall be as follows:-

- i) Execution of the management schemes for the Ridge forests as the green lungs of Delhi ;
- ii) Protection of the boundary and boundary fences of the Ridge ;
- iii) Preparation and execution of detailed plans for upgradation of the Ridge in accordance with sound sylvicultural and practices applicable to city forests and nature resources;
- iv) Control of the usage by the public of such areas of the Ridge forests as may be declared as "open", by the 'Board'.
- v) Ensuring that there are no encroachments in excess of the areas allotted to the lawful allottees, till they are shifted from the Ridge forest under appropriate orders.

- vi) Any other functions ancillary to the above purposes.
- (3) The Board may co-opt for any of its meetings not more than two persons having special knowledge of forestry, regional ecology, nature conservation and related subjects.
